NEIGHBOURHOOD WATCH UPDATE

The Neighbourhood Watch scheme continues to promote the security and safety of the residents of the IDRA area

Since the inception of the scheme in late 2022, we have had regular monthly meetings with the Community Gardaí on the first Thursday of every month at Fitzgibbon Street Garda Station at 7pm. Everyone is welcome to attend, not just street coordinators. At the meeting we review and discuss the crime statistics for the previous month and can raise any issues or concerns we have.

The area coordinator, Andrew Quinn provides a copy of the crime stats and notes from the meeting to the various WhatsApp groups that have been set up for the streets currently in the scheme.

We recently had a meeting in the Maples House Hotel where we have another four streets about to join the scheme.

Thanks to residents reporting suspicious incidents and increased Garda patrols in the IDRA area, reported crimes have continued to fall.

Finally, since the last AGM we have had a change of Community Gardaí; Sarah Heaney and Damien Curley have moved onto another type of responsive policing and we must thank them both for all their help and assistance during their time as Garda contacts. There replacements Joe Redmond and Sean Sammon have stepped up to the plate and have been very helpful during their short time in place. They will be in attendance on the night of the AGM to give a Neighbourhood Watch presentation.

IDRA PLANNING UPDATE

PLANNING ISSUES ARISING IN 2024

Over 2024, domestic planning applications comprised mostly rear extension, attic conversions and a few mews type houses in the rear gardens. All but one were granted permission.

Commercial planning applications included

1-2 St. Joseph's Avenue, 1 Whitworth Road - both refused and 1A Carlingford Road - awaiting decision on an appeal to An Bord Pleanála.

ENFORCEMENT ISSUES

Quinn's Pub Drumcondra Road Lower and adjoining premises up to St. Alphonsus Lane. There is no record of any current planning application on this site. IDRA has been engaging with Dublin City Council's Enforcement Section (Ref No. E0717/24).

OTHER ISSUES

Daneswell Place (Former Smurfit site)

IDRA is aware of a Dublin City Council Housing Delivery Report for October 2024 which shows all of the 160 apartment as permitted (a duplex housing block with eight units to be sold separately) will be allocated for Social Housing - all to be provided and rented out by Co-Operative Housing Ireland (CHI).

TRAFFIC UPDATE

Levels of through (rat run) traffic continue to rise. Ireland's vibrant economy means that the city continues to grow; infill developments are leading to higher densities of vehicle use and return to office means there is more traffic. All these factors combined mean more vehicles on the road, and more passing through lona District.

The various BusConnects projects have received approval, and construction is due to start on these in coming months, if not weeks. Increased availability of buses will be a positive for public transport users. Based on past experience, construction will prompt more drivers to seek short cuts. Higher densities of buses may crowd out cars, again prompting vehicle drivers to seek shortcuts. Drivers who discovered these streets as shortcuts during the working week use them during the evening and weekends.

We can see the rising volumes and speeds in the data, and we experience these trends in tailbacks on Iona Road, St Patrick's Rd, Lindsay Road and Hollybank Road. We see them in cars passing through in the late evening and early morning and hear them during weekends.

Over the past year we put resources into two initiatives. The first we hoped would lead to engagement with DCC, the second was hoped to demonstrate some of the amenity benefits of traffic management. Unfortunately, these did not come to fruition. Our next step will be to engage with elected representatives with the aim of leveraging their knowledge of the workings of DCC to meet the aims of the community to deliver the sorts of solutions that can tackle rising vehicle impacts.
